RESOLUTION NO. 98-R- 010

**A RESOLUTION PROVIDING FOR THE CREATION OF A
COUNTY NOXIOUS WEED LIST**

WHEREAS, pursuant to the Colorado Noxious Weed Act, §35-5.5-101, *et seq.* (and particularly §35-5.5-105) C.R.S., the State of Colorado has mandated that the board of county commissioners of each county in the state shall adopt an undesirable plant management plan for all of the unincorporated lands within the county; and

WHEREAS, the Delta County Weed Management Advisory Commission, made up of local landowners, municipal, county, state and federal representatives, as appointed by the Board of County Commissioners of Delta County, has developed a plan for Delta County, the implementation of which is deemed to be in the best interests of the residents of the incorporated municipalities and unincorporated areas of Delta County; and

WHEREAS, pursuant to §35-5.5-109, C.R.S., the local authority shall designate undesirable plants for purposes of the Act within its respective jurisdictional boundaries; and

WHEREAS, the Delta County Weed Management Advisory Commission has recommended that the list of weeds shown on Exhibit A, attached hereto and by reference made a part hereof, be the Noxious Weed List applicable to Delta County; and

WHEREAS, the Board of County Commissioners of Delta County is the designated local authority for the purposes of the Colorado Weed Management Act; and

WHEREAS, this Board conducted a public hearing with respect to this list of proposed noxious weeds on February 9, 1998, following notice by publication.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Delta County that the weeds described on Exhibit A, attached hereto and by reference made a part hereof, shall be and hereby are designated as "noxious weeds" for control purposes within Delta County, Colorado; provided however, that those weeds listed under Section 4 of Exhibit A shall be subject to control only on public lands, in public rights of way, and in public riparian areas.
